**Announcement and application information**

Each year the Flemish Government allocates research funds to Ghent University so as to implement the Flemish Government Resolution of 8 September 2000. In accordance with this resolution, Ghent University has drawn up rules and regulations regarding the funds of the Special Research Fund (*BOF, Bijzonder Onderzoeksfonds*)<sup>1</sup>. Each year the Research Council invites research proposals for the different initiatives.

## **Doctoral grants for researchers from developing countries:**

### **Objective**

Ghent University wishes to support university research groups or research centers in developing countries in their aim to grow into excellent research centres by upgrading local academic personnel. Therefore Ghent University grants PhD scholarships to promising PhD students from developing countries who wish to carry out half of their PhD research at Ghent University and half in a university in a developing country.

### **Scholarship type, duration and funding**

These grants take the form of a so called “sandwich” scholarship: the candidate obtains a scholarship for 24 months to work within a span of 48 months on an alternating basis on the PhD at Ghent University and at the university or research centre in a developing country. Only for the periods the scholarship holder works at Ghent University the scholarship holder will receive a monthly income. The rest of the PhD research is done in the partner university, for which no funding is provided through this scholarship. The amount of the scholarship is approximately €1.823 per month for the part of the PhD done in Ghent.

The Ghent University promoter also receives a bench fee of €15.440 to cover (part of) the operational costs, as well as part of the travelling costs of the student and both the Ghent University and the local promoter.

The 24 months of the scholarship must be divided into several periods within a span of 4 years. In principle the scholarship holder starts the scholarship at Ghent University during a period of 3 to 9 months and ends the scholarship with a stay of at least 3 months at Ghent University to complete and defend the doctoral thesis.

Students are obliged to defend their PhD thesis in Ghent unless there is a signed joint PhD agreement that allows students to defend their PhD thesis at their home university.

The grants are not renewable.

These grants are meant to result in a PhD degree from Ghent University but whenever possible, a joint PhD degree between Ghent University and the partner university is encouraged.

### **Admissibility**

To be admissible for this call, **all** of the following requirements **must** be met:

- Candidates need to come from – and have the nationality of – a developing country (see country list below)
- This program is limited to universities and research centers in developing countries (see country list below) with which Ghent University is already cooperating or has cooperated in the last 5 years. It is up to the Ghent University promoter to present evidence of this previous cooperation.
- There must be a guarantee that the candidate will be able to work on the PhD project at the partner university. This implies that there must be:
  - o A local PhD supervisor at the partner university or research center.
  - o A written and signed statement from that supervisor or the university authorities stating that the candidate is either a PhD student or a staff member of this university and will be sufficiently exempted from teaching or other assignments as to be able to fully concentrate on the PhD research.
  - o This statement should also mention that the candidate receives/received a local scholarship or salary when working on the PhD in the candidate's home institute.

No restrictions will be imposed relating to the fields of research, nevertheless preference will be given to topics that are relevant for **development**. Relevance for development measures the degree in which the action of development corresponds with the expectations of the beneficiaries, the needs of the country, global priorities and the policies of partners and donors.

The following principles are taken into account when measuring a project's relevance for development (determined by the Law of May 25<sup>th</sup> 1999):

- Does it strengthen the institutional management competence?
- What is the economic and social impact of the project?
- What is the educational and cultural impact of the project?

- What is the technical and financial feasibility of the project?
- How efficient is the implementation plan?
- Is the project non-discriminatory?
- Are environmental concerns been taken into account?

In an academic context, these principles are translated into the following criteria for selection and evaluation:

- Does the project strengthen the institution's capacity in a local context?
- Is the researcher incorporated in a research group in the developing country?
- What are the possibilities for validation of the acquired knowledge?

### **Language**

The applications for doctoral grants for candidates from developing countries are to be submitted in English.

### **Evaluation of applications and granting of the scholarships**

The Research Council makes a selection of the applications based in part on the recommendations obtained from members of the Council for Development Cooperation (*COS* or *Commissie voor Ontwikkelingssamenwerking*) and proceeds to formulate well-founded recommendations for the Executive Committee of the university. The recommendation is based on the evaluation of

- the doctoral project
- the relevance of the research topic for development
- the qualifications of the applicant for the doctoral grant
- the scientific/scholarly potential of the promoter's research group(s).
- the partnership between Ghent University and the local institute
- the scientific/scholarly potential of the local institute.

The doctoral grants for candidates from developing countries will be awarded by the University Executive Committee on the basis of an informed recommendation by the Research Council.

### **Selection result**

All promoters will receive a letter from the Rector with the selection result. Details on the feedback procedure will be mentioned in this letter.

### **Success rate**

This call is highly competitive. The success rate for this programme for 2012 was approximately 33%.

### **Scientific/scholarly report**

Within one year following upon the end of the grant a final scientific/scholarly report must be submitted, signed by the promoter. It will present the current state of affairs in the research project. The scientific/scholarly report must be made on the required forms, which are available on the University website <http://www.ugent.be/en/research/opportunities/phd/docos.htm>

### **Submission of the application**

The applications for doctoral grants for candidates from developing countries must be submitted on the forms provided for this purpose at <http://www.ugent.be/en/research/opportunities/phd/docos.htm>

The promoter has to fill in a separate document with advice on the candidate, stating the promoter's opinion on the capability of the candidate as a future researcher. ### **PART I – Data of the Applicant**

#### **1. Administrative information**

##### **1.1 Title of the doctoral research**

##### **1.2 The candidate**

##### **1.3 Ghent University promoter (only one allowed)**

The proposals must be submitted by a promoter who is, at the moment of the deadline of this call, associated with Ghent University either as:

- (a) a member of the tenured academic staff (*Zelfstandig Academisch Personeel*)
- (b) a visiting professor with at least a research assignment
- (c) a tenured senior research associate (*onderzoeksleider*) or research director (*onderzoeksdirecteur*) of the *FWO-Vlaanderen* (the Research Foundation Flanders)

This promoter acts as the **sole** authorized person for the granted research budget (*WBS-element*) and as spokesperson.

The promoter is required to date and sign the application in the space provided for this purpose.

In their capacity as promoter, promoters attest to the qualifications and capability of the candidate to successfully complete the doctorate.

##### **1.4 Ghent University co-promoter (only one allowed)**

The co-promoter has no access to the budget (*WBS-element*) for this BOF funding. As is evident in the project description and the plan of work, the co-promoter must make a real contribution to the coordination of the doctoral research.

At the moment of the deadline, the copromoter must:

- have an appointment at Ghent University (including “FWO postdoctorale onderzoekers” en “IWT onderzoeksmandaten”), the University Hospital, VIB, IMEC, IBBT and/or Vlerick Leuven Gent Management School **and**
- have a PhD degree

The status of the co-promoter (including the type and duration of the appointment) and the home institution have to be specified in the application forms. The role of co-promoter cannot be combined with an appointment to the account of the BOF budget.

The co-promoter must also date and sign the application in the space provided for this purpose.

##### **1.5 Researcher involved in the project (*if applicable*)**

Researcher within or outside the Ghent University Association who will make a contribution to the project. This researcher supports the research project in a substantial way without being a (co-)promoter.

The role of ‘Researcher involved in the project’ has no consequences with regard to (co-)promotership in future BOF funding.

### **1.6 Supervisor at the partner university or research centre in the developing country (obligatory)**

Give the name and details of the supervisor at the partner university or research centre who will be, jointly with a Ghent University promoter, supervising the PhD.

### **1.7 Research council committees**

In order to evaluate the applications, the Research Council and the Council for Development Cooperation rely on their own committees. The committees consist of members representing the following faculties:

Committee for the Humanities and Social and Behavioural Sciences ('Alpha' Working Group): Faculty of Arts and Philosophy, Faculty of Law, Faculty of Economics and Business Administration, Faculty of Psychology and Educational Sciences, Faculty of Political and Social Sciences

Committee for the Sciences and Engineering ('Beta' Working Group): Faculty of Science, Faculty of Engineering and Architecture, Faculty of Bioscience Engineering.

Committee for Biomedical and Medical Sciences ('Gamma' Working Group): Faculty of Medicine and Health Sciences, Faculty of Veterinary Medicine, Faculty of Pharmaceutical Sciences

As a rule, the application will be discussed in the Committee to which the promoter's faculty is assigned. If it is preferred that the application is discussed in another or several committees, this can be requested and motivated (e.g. cross-faculty cooperation).

### **1.8 Possible ethical and/or bio-safety implications**

Indicate whether one's project proposal may possibly have ethical and/or bio-safety implications. More in particular, the candidate needs to indicate whether:

If the committee for ethics gives the project a negative evaluation, as a rule this project cannot be set up. Only if the project proposal is changed and the ethical and/or bio-safety implications are no longer relevant - without altering the project's feasibility and innovation - the modified project can be carried out.

For the bio-safety dossier, please mention the code (Txx-xxxx) and the number of the activity as registered at the Office of the Environmental Coordinator. It is not necessary then to enclose the bio-safety dossier as an annexe.

It is important that the candidate will be sufficiently exempted from teaching or other assignments as to be able to fully concentrate on the PhD research. **A written and signed statement of the partner university concerning this exemption is required.** This statement should also mention that the candidate receives/received a local scholarship or salary when working on the PhD in the candidate's home institute.

At this stage this document can be a copy of the original letter, but in case the candidate is selected for the grant, the original signed letter will be required.

### **3. Contribution of the supervisor at the partner university or research center to the PhD research**

On maximum ½ page.

Describe the proposed research work within the framework of the research topics that the supervisor is currently studying or plans to study in the future. Indicate how the experience of the supervisor at the partner university or research center will contribute to the PhD research of the candidate.
