The International Islamic University Islamabad (IIUI), a public-sector university, invites you to quote for *Turnkey Solution for "Turnstile Access Control System" for Female Hostels* at IIU, Islamabad. - 2. The offers must be planned as per given Layout Plan (Annex-E), and should be submitted on company's letterhead as per formats given at (Annexure-A, B, C & D enclosed) to be duly filled. Offers without filling Annexure A, B, C & D will be rejected.
- 3. The bids comprise a single package containing <u>Two Separate Sealed Envelopes</u> are required to be delivered at IIUI latest by <u>10:30</u> a.m on <u>02-08-2017</u>. Tenders will be opened on same date at <u>11:00 A.M</u> in the presence of bidders who desire to attend. Each envelope shall contain separately the financial proposal and the technical proposal. The envelopes shall be marked as "FINANCIAL PROPOSAL" and "TECHNICAL PROPOSAL" in bold and legible letters to avoid confusion. Initially, only the envelope marked "TECHNICAL PROPOSAL" shall be opened. The envelope marked as "FINANCIAL PROPOSAL" shall be retained in the custody of the IIUI without being opened. The financial proposals of bids shall be opened publicly at a time, date and venue announced and communicated to the bidders later on.
- 4. Sealed tenders addressed to the Addl. Director (P&S), Room No. 109 1st Floor, Admin Block, New Campus, International Islamic University, Sector H-10 Islamabad may be dropped in person or mailed through courier, registered post; but it must be ensured that the same reaches our office well in time as late offers will not be considered. TERMS & CONDITIONS

- 1. Earnest Money: Tender must be accompanied by required earnest money in form of pay order/ call deposit/ Demand draft in favor of International Islamic University Islamabad. No offer will be entertained without earnest money. The Earnest Money will finally be adjusted to Performance Security/ refunded on completion of the contract. At any stage if the IIUI finds any bidder being indulged in providing wrong information, corrupt or fraudulent practices, intended to withdraw the bid during the validity period of bid/tender evaluation process or making the defective/incomplete/late delivery of IIUI Supply Order, the earnest money will be forfeited. The earnest money of unsuccessful bidders will be returned once the award of contract is announced. However, the earnest money of selected firm/contractor will be retained till successful completion of contract as per terms & conditions specified in supply order/contract agreement.
- 2. **Validity of Bid:** The offers (technical and financial) shall remain valid for our acceptance for at least **90 Days** from the date of opening of tender.
- 3. **Bid Submission:** The bids must be submitted in due course of time specified by IIUI for tender submission. The quotations received late (after opening the tender) will not be considered. Cutting/ over writing are not allowed, unless/ until authenticated under proper signature of the authorized person.
- 4. <u>Form of Contract</u>: After finalization of evaluation process of bids, the formal supply order/written contract agreement with terms & conditions would be made between IIUI and supplier as per rules.
- 5. Payment: The payment of FOR based procurement would be made after delivery of complete order through crossed cheque in favor of the SUPPLIER OR AUTHORIZED DEALER in Pak Rupee against the Invoice/Bill/GST Invoice/Delivery Challan submitted in formal to the IIUI.

Note: Any representation for complaining the delay of payment will not be accepted, until complete required documents for FOR bid (Invoice/GST Bill/Delivery Challan and Performance Bond) have not been received. (Countdown starts when Purchase & Store Section, IIUI receives complete requisite documents).

- 6. Delivery (FOR bid): Complete items must be delivered brand new and unused in standard packing (where required) as per ordered specifications/technical standard and free of defects/faults within 60 days after issuance of Purchase Order. Delivery of the ordered items at the IIUI's premises will be Supplier or his Authorized dealer's responsibility. After delivery, Bill/GST Invoice/Delivery Challan to be provided by the supplier to IIUI. Publications/Literature/Catalogues relevant to the supplied items in Hard Copies/CDs and Warranty/Guarantee certificates (where applicable) will be provided along with the Supply.
- 7. Terms of Liquidate Damages, Delivery Failure & Termination: The Supplier OR his nominated Authorized Dealer will be bound to the terms specified herein to be implemented as per discretion of IIUI in lieu of liquidate damages.

- 8. In case the supplier /contractor failed to deliver the stores within specified delivery period, IIUI shall have the following options:
 - i. To recover liquidated damages on account of late delivery, 2% of total purchase order value per month or part thereof will be imposed. The maximum limit of liquidated damages will not exceed 10% of contract value. Such damages shall be recovered from the earnest money, performance security bond and or by withholding any amount due to be paid against this or any other purchase order.
 - ii. To purchase from elsewhere, without notice but at risk and cost of Supplier or Authorized Dealer, the stores not delivered within the stipulated period and to recover excess value so paid by us from your security moneys and/or to cancel the contract at supplier's risk and cost.
- 9. In case of defects/faults of supply, IIUI shall have the following options;
 - i. Rectification of defects being found in the supplied stores at the supplier's risk and cost whether be done through supplier's source or any else if asked by the IIUI.
 - ii. Replacement of defective supply of stores as determined by the IIUI within the given/specified period.
 - iii. Deduction of amount equivalent to price of rejected items or part thereof from the supplier's payment/Securities those found with operational/physical problems at the time of installation/operational testing/inspection.
- 10. <u>Inspection:</u> The physical inspection of supplies shall be carried out at IIUI and the Receiving and Inspection Report of IIUI will be binding on the supplier.
- 11. <u>Warranty/Guarantee</u>: Supplier shall ensure to supply the stores in accordance with the ordered items/specifications and give standard warranty/guarantee of original/genuine products (where applicable). The supplier will provide a comprehensive **02 Years** or **as per Manufacturer's** Warranty policy in this behalf after supply of order on account of warranty terms.
- 12. <u>Performance Bond/Retention Money</u>: If deemed necessary the supplier will provide Performance Bond (refundable) equivalent to 10% of total contract value for a period not less than one year from the date of supply. In this regard, 10% amount of supply order will be retained from supplier's payment. The earnest money deposited by the supplier can be adjustable to Performance Guarantee amount if requested by the supplier and as deemed appropriate to IIUI.
- 13. <u>Technical Support</u>: It is responsibility of the supplier or authorized agent of supplier to satisfactorily complete the supplies as per supply order, which includes installation, testing and IIUI's acceptance/ inspection thereof. In case of certain specialized equipment in which the expertise of operation is not available with IIUI, the vendor will have to provide necessary training to the IIUI staff/ faculty through his trained engineers/technical experts. The terms and conditions for such training may, however, be mutually discussed between the IIUI and the successful bidder, if so required. The Supplier/Manufacturer will provide free service, technical support and replacement of defective parts of items for the warranty/guarantee period.

14. Taxes (As and where Applicable):

- i. GST/CED will be paid by the **PURCHASER** to the **SUPPLIER'S** on production of a separately numbered 'Tax Invoice' showing the amount of sales tax and other details under section 23 of Sales Tax Act-1990.
- ii. Income tax will be deducted as per rule.
- iii. Any change in taxes/ duties levied by Govt. after opening of bids will be on account of bidder. No change in offer will be accepted later on.
- 15. <u>Blacklisting:</u> If the supplier failed to execute order as per laid down terms and conditions in the tender/order or the performance is not satisfactory or are found to be indulging in corrupt or fraudulent practices, the action for blacklisting of firm/ supplier/ contractor will be taken as per PPRA rule 19. In case of any dispute, the case will be referred to President IIUI whose decision will be final.
