Tenders must be in a sealed cover and on the envelope, it must be written in bold letter "**TENDER FOR SUPPLY OF BRANDED COMPUTERS (RE-FURBISHED A+)**" to be opened on **04-07-2017** & should be sent in the name of Assistant Director-II(P&S), International Islamic University Administration Block New Campus, Sector H-10, Islamabad.

10. The University reserves the right to reject all bids in terms of Section-33 of Public Procurement Rules, 2004.




