


## TENDER NOTICE



**TERMS AND CONDITIONS:**

- i. The bidder should be registered with Income Tax and Sales Tax Departments appearing Active Tax Payer List of FBR.
- ii. Bidders should submit valid Ticketing License issued by the Govt. of Pakistan.  
Rates to be quoted on credit bases; however mode of payment mode will be negotiated with selected bidder.
- iii. Name of Airline with confirmed seats and itinerary be mentioned in the quotation.
- iv. Airline quoted by the bidders will be evaluated in terms of reputation and facilities provided to the passengers. Selection will not be made merely on the basis of lowest rates, other aspects like airline, rout etc will be kept in view.
- v. Two complimentary return tickets for KSA will have to be provided.
- vi. The details of Passengers will be provided in the work order.
