

- The bidder should be registered with Income Tax and Sales Tax Departments appearing Active Tax Payer List of FBR (Evidence must be enclosed with bid document)
- ii. Bidders should submit valid ticketing License (IATA approved).
- iii. Rates are to be quoted on credit basis. The Academy will pay 50% payment on receiving of 22-economy class alr tickets for full study tour and remaining 50% payment will be made within one month after successful completion of tour.

- xii. Attested affidavit from Oath Commissioner should accompany the bid, stating that the firm has never been blacklisted or declared disqualified by any government organization during fulfillment of its responsibilities in any contract and is not in the process of litigation with any government organization. The tender will be rejected straightway without assigning any reasons if the firm declared black listed by any Govt. /Seml govt. department/agencies etc.
- xiii. All the rates must be quoted in Pakistan Rupees.
