




1. Sealed tenders along with earnest money of **Rs.50, 000/-** in shape of Pay Order or Call Deposit in favour of "International Islamic University, Islamabad" must reach to the undersigned on **16<sup>th</sup> August, 2021 up to 10.00 a.m. including Rs.1,000/- as tender fee (non refundable)** The tender will be opened on the same day at 11.30 a.m. in the presence of the bidders/their representatives who may like to attend the opening ceremony.
2. Tender received after the due date/time, lesser earnest money and false statement or over writing will not be entertained.
3. Tender must be in a sealed cover and on the envelope; it must be written in bold letter **"TENDER FOR SUPPLY OF BATTERIES"** and should be sent in the name of Deputy Director/In-Charger Transport, Sector H-10, IIU, Islamabad.
4. The successful bidder will have to execute a running agreement initially for a period of one year on terms & conditions to be agreed mutually between the first party (IIUI) and second party (supplier/bidder) extendable for further period.
5. Quality/quantity/make/type of Batteries must be ensured by the firm/supplier. In case of supply of sub-standard Batteries, the firm/supplier shall be bound to bear the loss occurred to the purchaser.
6. Damaged supply will not be accepted (if any)
7. The IIUI being an Educational Institute be offered special discount on retail/factory prices etc.
8. The current price list of the batteries may be furnished. Increase in prices will be accepted on provision of orders issued by the FBR, Govt. Manufacturer from time to time with justifications.

9. GST/NTN Number must be mentioned/provided with letter issued by FBR, Government of Pakistan.
10. The supply of batteries will have to make within stipulated period to be specified by the IIU in its supply order(s). In case of failure or the extension in due period was not approved, 2% LD charges per day on the total value of the order will be imposed.
11. Taxes, levies and duties will be charged as per Govt. rules (if applicable)
12. Earnest money of the successful bidder will be refunded on completion/ ended of contract. In case, the supplier(s) does not act upon the instructions/procedure mentioned above, the earnest money will be forfeited.
13. Bids will be assessed/considered and job will award to the successful bidder.
14. As per clause - 33 of PPRA Rules 2004, the University reserves the rights to accept or reject any/all bid(s)/tender(s)



