Subject: Fee Structure for Faculty of FMS For the upcoming Semester Fall 2022

With reference to the approved minutes of the committee regarding the revision of fee structure for the Semester Fall 2022 under the Chairmanship of VP(R&E), the Fee structure for the faculty of FMS for the upcoming Semester Fall 2022 intake as recommended by Dean FMS fee waiver will be given to the students getting new admission w.e.f. Fall 2022 as per following manner:

Fee Waiver for Certain Programs in the Faculty of Management Sciences (w-e-f Fall 2022):

Sr. #	Percentage Marks Obtained	Per Cr. Hr. Fee
1	85% and above marks	Rs. 2000/-
2	75% and above marks	Rs. 2500/-
3	65% and above marks	Rs. 3500/-
4	50% and above marks	Rs. 4500/-

Conditions for Awarding Fee Waiver:

It is pertinent to mention that the fee waiver will be awarded on the implementation of the following conditions:


- The student may have taken the maximum work load as offered by the department in the relevant program.
- The student must not be having any outstanding dues (semester fee/or hostel dues).
- In case the student is availing any other scholarship the remaining tuition fee deposited by the student shall be refunded/adjusted.
- No disciplinary action should have been taken against the student concerned.
- The student will only be given waiver in the tuition fee.
- The student did not have any dropped/repeat course.
- The students who will be awarded fee waiver shall not be eligible for the merit scholarship.

- In case a student fails to maintain the said percentage in the subsequent semester, the student is required to deposit the full fee throughout the degree program. No waiver in tuition fee will be granted.

Furthermore, this subsidy/waiver in fee will be given only to the newly admitted student's w.e.f. Fall 2022 in BBA, BS Accounting & Finance and MBA degree programs and not for any other degree programs. This should also not be treated as precedence in any case. However it is pertinent to mention that the merit scholarship will remain intact for these programs prior to the Fall 2022 semester.

It is further highlighted that for the rest of the programs the previous fee structure will remain intact (attached at F/B)

It is now requested that same information may be updated in the admission guide (fee structure) and IIU website for the information of all concerned.
