1. All clauses of the terms and conditions shall be binding on the bidder.
2. Original Manufacturer / Authorized Distributors (*with valid authorization / distribution certificate*) / Suppliers registered with Income Tax, Sales Tax Department and who are on Active Taxpayers List (ATL) of FBR, are eligible to participate in tender.
3. **Purchase Procedure:** Procedure of open competitive bidding shall be: **Single Stage - Two Envelopes Procedure.**
4. **Submission of Bids:** The bid should be submitted in sealed envelopes up to the specified deadline and only Technical Bids will be opened as per schedule in the presence of available bidders or their representatives who may like to attend the bid opening.

6. The envelopes shall clearly bear the words “**Confidential**” and accompanied by identification worded as Tender For “*Purchase of Computers/Lab Equipment for DECE (Male)/DME/DCE/CAEPE/DECE(Female) (as given on the BOQs of this document)*”.
7. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
8. **Tender Fee:** Bidders are required to submit a Pay-Order/CDR/BC as per tender fee Rs.3,000/- for each tender (non-refundable) mentioned in Tender Notice along with Technical Proposal.
9. **Earnest Money:** The bidder is required to furnish in form of “CDR” equivalent to **2%** of the total financial Bid price (in PKR) as Earnest Money (Refundable) in favor of “International Islamic University Islamabad”. **Any bid not accompanied by the Earnest Money shall be rejected without any right of appeal.** The earnest money shall be enclosed with the Financial Proposal in sealed envelope and its particulars, like issuing bank name and CDR number with date shall only be mentioned on the envelope without mentioning the amount.
10. The BID (Tender) submitted shall comprise of a single package containing two envelopes, each envelope shall be marked and will contain “**TECHNICAL**” and “**FINANCIAL**” proposal.
11. On the given tender opening date only “**Technical Proposal**” will be opened in the presence of tenderers available.
12. The “**Financial Proposal**” shall be shown to the parties but will be retained with IIU without being opened.
13. After Technical Evaluation of the received Technical Proposals, Financial Proposals will be opened publicly at the date, time & venue to be announced and will be communicated to the bidders in advance.
14. IIU will open the “Financial Proposals” publicly of the parties whose Technical Proposals have been found acceptable.
15. Financial Proposals of the technically disqualified bids shall be returned **un-opened** to the respective bidders.
16. Installation, testing, commissioning and training etc. of supplied Lab Equipment(s) is the sole responsibility of the vendor without any additional cost/charges.
17. **Delivery Time: Maximum up to 60 Days** after issuance of Supply/Purchase Order.
18. The bid proposal(s) should be inclusive of all taxes and duties prescribed by the government from time to time, on “FOR Basis” as per BoQs Format (Items deliverable to International Islamic University, New Campus, Sector H-10 Islamabad).
19. **Payment Terms:** Payment will be made after successful delivery of the items, installation at respective lab and inspection by the Inspection Committee.
20. **Performance Security:** 10% of the total value of supply order will be deposited by the successful bidder(s) within 10 days after issuance of Purchase Order as **Performance Guarantee/Security** in the form of CDR in favor of “International Islamic University, Islamabad”.
21. *Performance Guarantee/Security @ 10% of total value of supply order shall be retained by the IIU till the successful completion of the warranty period of the goods/services/works.*
22. Earnest Money of the successful bidder(s) will be released upon deposit of Performance Guarantee/Security. If successful bidder(s) fails to deposit Performance Security within due date then Earnest Money will be forfeited and supply order will also be cancelled.
23. After opening of bids, International Islamic University Islamabad will examine the bids for completeness as per tender document’s Terms & Conditions AND Technical Specifications as per BoQ.
24. Purchase order (s) will be awarded to the lowest evaluated and technically recommended bidder (s) on the basis of item wise / subtotal wise / grand total wise according to the nature of BoQs/Compatibility requirements.
25. The finding(s) of the Evaluation Committee shall be final for which clarification can be sought in terms of Rule-33 of PPRA Rules 2004.

26. **If the vendor fails to deliver the goods / services to International Islamic University, Islamabad or delays the supply without a cogent reason, the following actions will be taken to safeguard IIUI interest:**
- Late Delivery Charges will be charged @ 02% per month of the total Purchase Order value and up to the maximum limit of 10%/equal to performance security; LD Charges will be deducted from the invoice of firm concerned.
 - If the vendor fails to deliver the goods/services during the extended period (*if allowed*) then the purchase/work order may be cancelled, Performance Security will be forfeited and the IIUI also reserves the right to blacklist the defaulter.
27. If the delivered goods/services are not according to the required quality standards/specifications, the same shall be liable to be rejected after inspection. The bidder/vendor will be required to REPLACE as per requirements mentioned in our BoQs at no cost to the IIUI, otherwise the purchase / work order will be cancelled after due date with confiscation of Performance Security AND bidder will bear all cost and expenses thereof including actions proposed above.
