INTRODUCTION

Islamic Research Institute and Faculty of Shariah & Law, IIUI is offering RESEARCH AND **ACADEMIC** WRITING one-week workshop to facilitate topic selection, preparation of synopsis and its approval from the statutory bodies. The workshop will also enable the Postgraduate thesis writers/candidates to complete their research work well in time and submit thesis for the evaluation.

A Postgraduate thesis in law and its allied disciplines make a researcher capable of independently conducting original and credible research in the legal studies. This type of research contributes in a substantial, original legal knowledge and demonstrates a deep understanding of the subject area addressing a gap in existing scholarship or offering an innovative perspective of existing field knowledge in the of law jurisprudence. lt is expected that Postgraduate can produce research that is of interest to other professional researchers. He/she can have a command of the subject to the extent that he/she can evaluate the work of other researchers. Likely, motivation of a Postgraduate candidate is resolving around developing a trained mind for satisfying intellectual curiosity through fulfilling a lifelong ambition. A Postgraduate thesis must form a distinct contribution to the knowledge of the subject and afford evidence of originality, shown by the discovery of new facts, or by the exercise of independent critical power. Additionally, a Postgraduate thesis must show work which, if written in a suitable form would be publishable. For accomplishing this task, a researcher must be equipped with the tools, techniques, and strategies that are necessary to conduct effective legal research and produce high-quality academic and professional legal documents. He/she should be able to systematically study legal rules, principles, concepts, theories, doctrine, sources, problems, issues, questions with the aim of

achieving some new understandings, some truth, some reality etc.

HISTORY OF IRI RESEARCH AND ACADEMIC WRITING TRAINING PROGRAMS

The Islamic Research Institute has long been mindful of the need for proper research designing, data collection, appropriate writing skills, and technical editing of manuscripts before their submission to examination boards, journals, or the press. It also works to devise an internationally recognized format for technical editing. The constitution commission, which drafted the 1962 constitution, identified that there is a lack of trained and competent scholars in the Islamic literature. In the light of this report, the Institute prepared a large-scale training program for the researchers in 1962. In this training program, the researchers were to be trained in various languages as well as Islamic and contemporary sciences, so that they could contribute to the research activities of the Institute. The obligations of the Institute regarding training in research skills and foundational studies related to Islamic thought were introduced in 1963, which states that to achieve the aims and objectives of IRI, the first and foremost need is to train and prepare the researchers scientifically. The Board Governors of IIU in its 82nd meeting held on 20-07-2018 on the recommendation of the Council of Islamic Research Institute in its 11th meeting held on 27-10-2017 approved IRI Research training programs. These programs designed to bring the researchers to a position where they can better understand dimensions of contemporary social sciences, legal studies and religious studies. They are equipped with latest research techniques so that they can produce quality research and present their conclusions in the form of dissertations, articles, reports, books, manuals and monographs.

AIMS AND OBJECTIVES OF THE TRAINING

This one-week Postgraduate Training is aimed to enhance research skills and techniques, so that a Postgraduate candidate can be able to demonstrate:

- The ability to recognize and validate problems of research in the field of law and Shariah and can incorporate it in his/her synopses and research proposal.
- 2. The capability to apply original, independent and critical thinking during the process of data collection thesis writing
- 3. The aptitude to develop theoretical concepts in view of the recent advances within one's field and in related areas.
- 4. An understanding of relevant research methodologies and techniques and their appropriate application within one's research field.
- 5. The capacity to critically analyse and evaluate one's findings and those of others through the review of literature and latest researches in the field.
- 6. The realization of the nature, purpose or policy objectives of legal rules on the area of research and to ascertain their relevance, utility, adequacy, efficacy etc.

Themes and Topics Covered in the Workshop

- Understanding of use of online sources and databases
- Introduction to use the sources to explain, discover, examine, analyze and present in a systematic way the concepts, doctrines, and theories of various legal concepts.

- Introduction to legal databases (e.g., Westlaw, LexisNexis, HeinOnline)
- Effective use of case law, statutes, and secondary sources
- Citation management tools (e.g., Zotero, EndNote)

- Structure and components of legal documents (e.g., essays, dissertations, case notes)
- Crafting clear and concise legal arguments
- Avoiding common pitfalls in legal writing

5. Advanced Legal Analysis

- Techniques for analyzing case law and statutes
- Synthesizing legal principles and applying them to new scenarios
- Critical evaluation of judicial reasoning

6. Use of Technology in Legal Research

- The role of AI in legal research: tools and applications
- Using Al-powered platforms for case law analysis, legal drafting, and predictive analytics
- Ethical considerations and limitations of Al in legal research

7. Referencing, Citation, and Plagiarism Policies

- Understanding legal citation styles (e.g., Chicago Manual of Style, OSCOLA, Bluebook)

- Tools for detecting and preventing plagiarism (e.g., Turnitin, Grammarly)
