- 1. Any addition, deletion, or modification of any clause of the procurement terms & conditions of Shariah Academy, International Islamic University Islamabad (IIUI) by any vendor will not be acceptable and may lead to rejection of the bid.
- 2. Original Manufacturer/Authorized Distributors (With Valid Authorization/ Distribution Certificate) / Suppliers registered with Income Tax, Sales Tax Department, and who are on the Active Taxpayers List (ATL) of FBR, are eligible to participate in the tender.
- 3. Documents along with CDR/Pay Order/Demand Draft amounting to Rs 5,000/- as a tender document Fee (Non-Refundable) shall be submitted in favor of Shariah Academy, IIUI, to the address given below. Part/Advance payments is not allowed.
- 5. The exact completion/delivery time from the date of the purchase/work order will be a maximum of 25 days. The handing over/completion time is critically important.
- 6. After the opening of bids, Shariah Academy, IIUI, will examine the bids for completeness as per the tender document.
- 7. Purchase order will be awarded to the technically recommended and lowest evaluated bidder who meets the technical specifications on the basis of item-wise/subtotal-wise / grand total-wise according to the nature of BoQs/Compatibility requirements.
- 8. Payment Terms: Payment will be made after the successful delivery of the items, installation at the respective places, and inspection by the Inspection Committee.
- 9. The bidder is required to furnish two separate drafts, in the form of "CDR" @2% as earnest money & other is for Performance Warranty @10% of the total cost of the bid in favour of Shariah Academy, IIUI. The Earnest Money/Bid Security of the successful bidder(s) will be released upon the receipt of the Performance Warranty CDR in favor of Shariah Academy Own Sources, Account No: 50067900427851. (HBL)
- 10. Performance Warranty @ 10% of the total value of the supply order shall be retained by the Shariah Academy, IIUI, and 50% of the Performance Warranty shall be released upon successful delivery of items, while the remaining 50% be retained until completion of the warranty period. (including free maintenance and support) of the goods/services/works.
- 11. Shariah Academy, IIUI, will follow the **Single Stage One Envelope** procedure as laid down by the PPRA rules.
- 12. Bidders cannot challenge the findings of the evaluation or ask for reasons of disqualification.
- 13. The bid should be submitted in a sealed envelope up to 08-09-2025 (Monday) on or before 10:30 a.m., and the proposals (Financial) will be opened on the same date at 11:00 a.m. in the presence of available bidders.

- 16. If the vendor fails to deliver the goods/items to Shariah Academy, IIUI, within a given time, then the penalty will be imposed/charged as under:
- a) Late Delivery Charges will be charged @ 02% per month of the total Purchase Order value and up to the maximum limit of 10%; LD Charges will be deducted from the invoice of the firm concerned.
- b) If the vendor fails to deliver the goods/items during the delivery time or extended time period (if allowed) then the purchase/work order may be cancelled, Earnest Money will be forfeited, and the Shariah Academy, IIUI, also reserves the right to blacklist the defaulter as per PPRA rules.
- 17. If the delivered goods/items are not according to the required quality standards/ specifications, the same shall be liable to be rejected after inspection. The bidder/vendor would be required to REPLACE as per the requirements mentioned in our BoQs with no cost liability to be paid by the Shariah Academy, IIUI. The







purchase/work order will be cancelled after the due date with confiscation of earnest money, AND the bidder will bear all costs and expenses thereof.

- 18. All prices should be quoted on a FOR Basis (inclusive of all applicable taxes).
- 19. All prices should be valid for at least 90 days (extendable by another 90 days), withdrawal or any modification of the original offer within the validity period shall entitle Shariah Academy, IIUI to forfeit the earnest money in favor of the Shariah Academy, IIUI and/or put a ban on such vendor participation in Shariah Academy, IIUI tenders/works.
- 20. It is the sole responsibility of the bidder/agent/supplier/manufacturer to comply with the applicable laws, be national or international (if any).




