| 7. | Justification for Revision of Scheme of Studies | Board of Governors in 60 th meeting held on February 14, 2009 while discussing the duration of B.A, LL.B. (Hons) Shariah & Law Program observed as under: “It was agreed that since we are offering substantial courses in Shariah (Islamic Law) in addition to the courses prescribed by the Pakistan Bar Council, spread over five years, the duration of the program was extended to six years (after 12 years higher secondary education). The board did not agree to offering of the 21 credit hours in a semester. The Board further agreed that the IIU degree of B.A, LL.B. (Hons) Shariah & Law is valued and recognized because the graduates are trained in Common Law as well as Shariah (Islamic Law).” |
