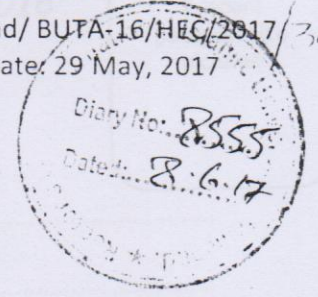

The Higher Education Commission confers "Best University Teacher Award" to encourage and recognize the contributions of outstanding university teachers in their fields and to acknowledge their achievements by providing them an incentive to improve their efficiency enabling them to address the challenges of international competition in higher education sector.

2. Each award is given in terms of a certificate along with a cash prize of Rs.100, 000/- (Rupees One Hundred Thousand Only).

3. All details, **Terms & Conditions alongwith Revised Form** are available at HEC website <http://hec.gov.pk/site/buta> Teachers of following categories of Universities are eligible for the award:

- i. All Public & Private Sector Universities/DAI's (recognized by the HEC) established in 2014 or before (completed minimum 3 years of establishment).
- ii. Only those teachers can be nominated by University/DAI who have minimum three years consecutive/active service as a permanent faculty of the concerned University/DAI up to 31st December 2016. TTS & Contract Teachers, fulfilling all other criteria are also eligible.

4. You are accordingly requested to widely disseminate the information to all the departments and constitute a Committee under your kind chairmanship, comprising the Registrar, Director Quality Enhancement Cell (QEC), Dean of the relevant faculty and HoD of the relevant department/institute to nominate two top scoring teachers from your University/Institution for selection of one Best University Teacher for the year 2016 by the HEC. The Quality Enhancement Cell (QEC) may be involved to help with the evaluation process.

5. The nomination proforma, completed in all respect **with all supporting documents as indicated in terms & conditions**, should reach this office by **14th July 2017**. The Scoring Sheet of all the teachers evaluated for the said award also be enclosed. Incomplete nominations as well as nominations received after the due date will not be entertained.
