HEC-Need Base Scholarship for Fall 2020

- e) 1st Semester fee will be required to submit by the student and would be refunded if the student is selected for scholarship.

- The applicant can only obtain the Need Base Scholarship form from university website "www.iiu.edu.pk/scholarships/HEC Need base scholarships".
- The duly filled HEC-NBS form should be sent through courier to given below address along with all supporting documents.
- Incomplete forms without all supporting documents will not be entertained.
- IIU will review the applications and only shortlisted candidates will be called for interview.
- The authenticity of the information would be verified by cross-checking of the data provided.

Note: The students not selected for scholarship shall have to bear their fee at their own.
