## GENERAL TERMS AND CONDITIONS FOR HIRING THE SERVICES OF PRIVATE SECURITY COMPANY

#### Terms & Conditions:

- 1. The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Pre-qualification Proposal and the other envelope should contain the Financial Proposal, both showing the tender enquiry No\_\_ and marked as "PRE-QUALIFICATION PROPOSAL" and "FINANCIAL PROPOSAL" respectively.
- 2. The firm should be registered with Income Tax Department (Registration Number Should be clearly mentioned and valid documentary evidence be attached).
- 3. The firm should have a minimum of three (03) years experience of similar assignment and should have a proper setup/office at Islamabad/Rawalpindi.
- 4. The firm must be a valid license holder from Ministry of Interior and holding Clearance/performance certificate from Local Police, Special Branch & IB.
