# GENERAL TERMS AND CONDITIONS FOR HIRING THE SERVICES OF PRIVATE SECURITY COMPANY

#### Terms & Conditions:

- The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Pre-qualification Proposal and the other envelope should contain the Financial Proposal, both marked as " PRE-QUALIFICATION PROPOSAL" and "FINANCIAL PROPOSAL" respectively.
- 2. The licensed Security Firm should be registered with Income Tax and GST Department (Registration Number should be clearly mentioned and valid documentary evidence be attached).
- 3. The firm should have a minimum of ten (10) years experience of similar assignment and should have a proper setup/office at Islamabad/Rawalpindi.
- 4. The firm must be a valid license holder (All Pakistan) and holding Clearance/performance certificate from Local Police. Special Branch & IB.
- 5. The bidder will be required to submit a call deposit in form of Pay Order for a sum of Rs. 100,000/- (Rupees one hundred thousand only) for a contract period of approximately 12 months) as earnest money in favor of IIUI.
