


- Name of the firm, permanent address, Telephone number.

- The firm must be a registered firm.
- Establishing year.
- Details of work with other organizations/Departments.
- National Tax No. /GST No. along with certificate.
- Proof regarding manufacturing/authorized sole distributors.
- Copy of CNIC must be attached.

5. In case the job assigned to the firm, is not completed within stipulated period, **2%** of the value of job/supply, on weekly delay basis, will be deducted from the bill on account of L.D charges.

6. Payment will be made to the firm after satisfactory completion of the job/supply with the assurance of good standard (Genuine) Filters and on submission of bill (in triplicate) along with Inspection Certificate by the Inspection Committee of the University. Income tax/sales tax will be deducted from the bill as per rules.
