




2. Sealed tenders along with 5% earnest money (refundable) of total value of bid and tender fee (non-refundable) of Rs.1000/- (Rupees one thousand only) in shape of Pay Order or Call Deposit in the name of "Director (Finance), International Islamic University, Islamabad" must reach on 20<sup>th</sup> November, 2018 up to 10.00 a.m. The tender will be opened on the same day at 11.30 a.m. in the presence of the bidders/their representatives who may like to attend the opening ceremony.
3. Tender received after the due date/time, lesser earnest money, tender fee and false statement or over writing will not be entertained.
4. Tender must be in a sealed cover and on the envelope; it must be written in bold letter "**TENDER FOR SUPPLY OF BATTERIES**" and should be sent in the name of In-charge, Central Transport Unit, Sector H-10, IIU, Islamabad.
5. The successful bidder will have to execute a running agreement initially for a period of one year on terms & conditions to be agreed mutually between the first party (IIUI) and second party (supplier/bidder) extendable for further period.
6. Quality/quantity of batteries must be ensured by the firm/supplier. In case of supply of sub-standard batteries the firm/supplier shall be bound to bear the loss occurred to the purchaser. Laboratory check on the expenses of the manufacturer/firm/supplier will be carried out (if found necessary).
7. Damaged supply will not be accepted (if any)

8. The IIUI being an Educational Institute be offered special discount on retail/factory prices etc.
9. The current price list of the batteries may be furnished. Increase in prices will be accepted on provision of price list/orders issued by the Govt. /Manufacturer from time to time with justifications.
10. GST/NTN Number may be mentioned/provided with letter issued by the Govt. (FBR)
11. The supply of Batteries will have to make within stipulated period to be specified by the IIU in its supply order(s). In case of failure, 2% LD charges per day on the total value of the order will be imposed.
12. Taxes, levies and duties will be charged as per Govt. rules (if applicable)
13. Earnest money of the successful bidder will be refunded on completion of contract. In case, he does not act upon the instructions/procedure mentioned above, the earnest money will be forfeited.






