- 1. Any addition, deletion or modification of any clause of the terms & conditions of International Islamic University Islamabad (IIUI) by any vendor will not be acceptable and may lead to rejection of the bid.
- 2. Firms registered with Income Tax, Sales Tax Department and who are on Active Taxpayers List (ATL) of FBR are eligible to participate in tender.
- 3. Documents along with Pay Order/Call Deposit/Demand Draft amounting to Rs. 1000/- as a tender documents fee (Non-Refundable) shall be submitted in favor of International Islamic University, Islamabad, to the address given below.
- 4. After opening of bids, International Islamic University, Islamabad will examine the bids for completeness as per tender document.
- 5. Agreement/Contract (As per format attached at Annex-I) will be executed with the lowest evaluated bidder on the basis of item wise/subtotal wise/grand total wise according to the nature of BoQs/Compatibility requirements.

- 7. Bidders cannot challenge the findings of the evaluation or ask for reason of disqualification.
- 8. The bid should be submitted in a sealed envelope up to <u>07-11-2019</u> on or before <u>10:30 a.m</u> and will be opened on the same date <u>at 11:00 a.m</u> in the presence of available bidders.

- 11. The bid form (BoQs) must be duly filled in, stamped and signed by the authorized representative of the bidder.
- 12. All prices should be valid for at least <u>15 Months</u> Withdrawal or any modification of the original offer within the validity period shall entitle IIUI to forfeit the earnest money in favor of the IIUI and / or put a ban on such vendor participation in IIUI tenders / works.
- 13. It is the sole responsibility of the bidder / agent / firm to comply with the applicable laws, be national or international.
- 14. Rates of each item/process be quoted and complete package price will also be quoted. In order to avoid mixing of processes, firm low in complete package will be preferred.
- 15. Certificate from organizations where services are being provided must be attached.
- 16. Custom clearance charges will be paid by clearing agent at the time of release of equipment at the Airport/Dryport and will forward bill to this office for payment purpose subsequently.
- 17. Demurrage charges due to late clearance of equipment on Airport/Dryport will be paid by the clearing firm/agent and no force majeure will be applicable.
- 18. The firm will make elaborated arrangement for urgent/timely clearance of equipment from concerned Airport/Dryport. In case the firm fails to clear the equipment, the equipment will be got cleared through 3rd party or under IIU arrangement. The difference of rate will be recovered on Risk and Cost of the Firm.

- 19. International Islamic University, Islamabad (IIUI) is an Educational Institution and exempted from payment of custom duties and sales tax under Government of Pakistan Tariff No. 9915. While submitting proposal CPT, please indicate applicable taxes/duties separately so that the contract is concluded keeping in view the applicability/ exemption of these taxes/duties, accordingly.
- 20. In case of any dispute, decision of the President, IIUI will be final and binding upon the parties.

WHEREAS the First Party has agreed to execute an agreement with the Second Party for clearance/release of imported equipment against their quoted rates and the second party also agreed to provide their services for the same on the following terms and conditions:

- i. That this agreement is for a period of **ONE YEAR** (Extendable with the mutual consent of both parties) from the date of signing of this agreement.
- ii. It is the sole responsibility of the bidder / agent / firm to comply with the applicable laws, be national or international.
- iii. Custom clearance charges will be paid by clearing agent at the time of release of equipment at the Airport/Dry port and will forward bill to this office for payment purpose subsequently.
- iv. Immediately on receipt of complete import documents from the University before arrival of the shipment, clearing agent shall complete all formalities necessary for clearance from Custom Authorities promptly and expeditiously in order to avoid any delay in clearance of consignment.
- v. The clearing agent shall receive consignment arriving from abroad at Islamabad Airport/Dry port for clearance of the same from Customs Authorities and subsequently supervise its loading into vehicles for onward dispatch to the site.
- vi. The clearing agent shall arrange to complete delivery orders in all respects from the shipping agent immediately on arrival of the shipment.
- vii. The clearing agent shall take acknowledgement in writing from Store Section of IIUI that the goods duly cleared from Customs have been handed over to the Store Officer in exact quantity and sound condition.
- viii. Demurrage charges due to late clearance of equipment on Airport/Dry Port will be paid by the clearing firm/agent and no force majeure will be applicable.
- ix. The firm will make elaborated arrangement for urgent/timely clearance of equipment from concerned Airport. In case the firm fails to clear the equipment, the equipment will be got cleared through 3rd party or under IIUI arrangement. The difference of rate will be recovered on Risk and Cost of the Firm.
- x. The clearing agent will also clear any consignment coming through DHL if the University so desires.
- xi. That the first party will inform to the second party and formally issue an authority letter for clearance/release of imported equipment and the second party shall be bound to clear and deliver at the designated place of the first party.
- xii. Wherever University enjoys concession in Custom Duty, Sales Tax, surcharge etc as an educational institution, it will be sole responsibility of the clearing agent for availing such concessions.

xiii. Security Money deposited by the Clearing Agent will be refunded after successful completion/expiry of contract after adjustments, if any. No interest/dividend will be claimed on this amount. If the Clear Agent fails to fulfill the terms & conditions of this agreement/contract, the Security deposit will be forfeited. Payment: The clearing agent shall submit bills in triplicate along-with original sales tax xiv. invoices receipt/vouchers for each consignment soon after delivery of material at IIUI site and IIUI shall make payment of the clearing agent's bills if found in order as per quoted rates within 30 days from the date of submission. Penalties: In case of default at any time by clearing agent in carrying out the required job XV. in terms of this agreement, the IIUI reserves the right to terminate/cancel this agreement without any notice and assign the job to any other party at the clearing agent's risk and cost and to recover from him all excess expenditures incurred in this regard. Sublet: The clearing agent shall not sublet the contract for clearing of imported xvi. consignment to another party. xvii. In case of any dispute with regard to this Agreement, the matter shall be referred to the arbitrator and with the consent of the parties the President of the International Islamic University is a sole arbitrator whose decision shall be final and binding on both the parties and shall not be challengeable in any Court of Law.
